**Restrictions:** The Property of the Partners shall remain the property of its respective owner. The Property shall be used only in the manner set out in this Agreement.

**Independence:** The Partner and **allFerrets®** agree that as to each other, they are independent. Neither has the right to bind the other to any agreement with a third party. Nothing in this Agreement precludes, impairs, or restricts either the **allFerrets®** or the Partner from engaging in any other activity, including engaging in similar agreements and relationships with other entities, except if the activities involve a breach of this Agreement. Co-Sponsorship shall be addressed in a separate written agreement(s).

**Termination:** **This Agreement can be terminated by either Partner AT ANY TIME upon giving fourteen (14) days prior written notice.** Upon termination, each Partner shall immediately cease to name and display the other organization as a "Partner" on their website. However, each Partner understands that termination of the Partner Agreement does not hinder either organization from continuing to display the other's organization on its website for another purpose (e.g., included in a Shelter listing, news, advertisement, event, etc.).

**Representations and Warranties:** **The Partner and allFerrets® represents and warrants that it has the right to enter into this Agreement and that the terms of this Agreement are not inconsistent with any other contractual obligations by which the Party is bound.**
